Assessment/Grading

The grading of each module is partly based on individual or group case assignments and/or exercise assignments, and partly on a final exam. Each participant who passes the course and exam with a sufficient grade will receive a certificate of completion.

Entry requirements

Required degree

Bachelor's or Master's university degree in a related field (e.g., finance, business administration, economics, engineering, natural sciences, mathematics, law).

Work experience

A minimum of two years of relevant work experience in the financial field or with a financial organisation. Evidence of analytical and conceptual skills, a desire to strive for excellence, a proven capacity for hard work, and willingness to contribute to a highly diverse learning environment.

Candidates without a relevant Bachelor's or Master's degree or relevant work experience in the financial field first need to complete an online, self-study MIF Pre-Course Training (tuition fee: €1,000).

Online application

To apply for a MIF module, you need to fill out the registration form at abs.uva.nl/mif-module and submit it with the following documents:

- Curriculum Vitae
- Copy of passport
- University degree
- University transcripts

After receiving your completed application form we will evaluate your profile and contact you for an introductory meeting.

The registration deadline is two weeks before the start of a module.
